2. MSCPA Commissioner and Alternate Resolution

The Board approved Resolution #202 which appoints Mr. Mike Barber, Director as the Commissioner and Mr. David Mackie, Hillsdale City Manager as Alternate Commissioner to the Michigan South Central Power Agency Board of Commissioners (MSCPA).

Moved by Mr. Anderson, supported by Mr. Batt, Vice-President, to approve Resolution #202 which appoints Mr. Mike Barber as the Commissioner and Mr. David Mackie as Alternate Commissioner to the MSCPA.

Motion carried by unanimous voice vote.

3. Transformer Purchases

BPU's Electric Superintendent, Chad Culbert, solicited quotes for 15 KVA, 25 KVA and 50 KVA single phase pole mount transformers from four different vendors. This purchase will bring our transformer inventories up to the proper levels and last approximately two years. The Board approved the purchase of the pole mount transformers from the lowest bidder, Stuart C Irby, Company, for a cost of \$25,485.00.

Moved by Mr. Hill; supported by Mr. Batt, Vice-President to approve the purchase of pole mount transformers from Stuart C Irby Company for a cost of \$25,485.00.

Motion carried by unanimous voice vote.

4. BS&APurchase

A recommendation was made for the Board to approve the purchase of several modules from BS&A with a cost of \$103,825. The modules to be purchased would include:

- Fixed Assets
- Miscellaneous Receivables
- Human Resource
- Utility Billing
- AccessMyGov/Employee Self Services

With the payments as follows:

1st Payment - \$37,005 to be invoiced upon execution of this agreement.

2nd Payment - \$34,200 to be invoiced at start of training.

3rd Payment - \$32,620 to be invoiced upon completion of training.

Also approved was an ongoing Annual Service Fee for the above modules in the amount of \$7,520.

Mr. Anderson inquired if this had budgeted – Yes.

Mr. Anderson inquired about the timeframe of implementation which will be up and running by the end of the calendar year. Mr. Hill inquired why we couldn't start payments when we go live but B S & A requires 1st payment and signed contract to proceed.

Moved by Mr. Batt, Vice-President, supported by Mr. Anderson to approve the purchase of the above modules required for the BPU in the amount of \$103,825 to be paid in 3 payments.

Motion carried by unanimous voice vote.

HydroCorp Agreement

This contract is a continued effort for the ongoing Cross-Connection Control Program and will provide the Hillsdale Board of Public Utilities with the necessary data and information to maintain compliance with the Michigan Department of Environmental Quality (DEQ) Water Bureau Cross Connection Control Regulations.

A recommendation to approve the four (4) year contract with HydroCorp to continue our Cross-Connection Control Program for a cost of \$15,996.00 annually or \$63,984.00 over the term of the contract was presented to the Board.

Moved by Mr. Batt, Vice-President; supported by Mr. Anderson to approve the four (4) year contract with HydroCorp to continue our Cross-Connection Control Program for a cost of \$15,996.00 annually.
