Old Business

A. Special Election Costs/Candidates Filing Deadlines.

Mayor Sessions presented Council with a report prepared by Finance Director Bonnie Tew regarding costs to the City for special elections. Council reviewed the report and made inquiry asking questions of both City Manager Mackie and Interim City Clerk Loren. After considerable discussion, it was determined that Council did not care to hold a special election in May, 2016 but to revisit the matter in time for filing for the August, 2016 election date. Council member Stack-Davis requested reminders of the filing dates be included in future packets so they would not go forgotten.

New Business

A. MERS 457 Plan.

Human Resource Director, Kay Freese and MERS Representative Michael Tackett gave an overview of what the move of the employees' current ICMA Retirement account to the MERS 457 would look like. Council member Bell in particular made inquiry to satisfy that there was benefit to the employees for making this move.

Motion by Councilman Bell, supported by Councilperson Stack-Davis, to adopt Resolution No. 3256 approving the MERS Supplemental Retirement Program with Loan Addendum and authorize the Mayor and Clerk's signatures on the MERS 457 Participation Agreements and MERS Uniform 457 Supplemental Retirement Program Resolution. Roll call: Councilmembers Flannery – yes; Sharp – yes; Stockford – yes; Mayor Sessions – yes; Councilmembers Bell – yes; Stack-Davis – yes; Dixon – yes.

B. Annual MDOT Right of Way Permit.

C. Appointment of Interim DPS Director.

Mayor Sessions announced the appointment of Jake Hammel as Interim Board of Public Utilities. City Manager David Mackie gave an overview of Mr. Hammel's background and attributes. Mr. Mackie also stated that as the appointment is interim, Mr. Hammel will be up for review and possible permanent appointment as Director.

Motion by Council member Sharp, supported by Councilmember Flannery, to approve the appointment of Jake Hammel as Interim Director of the Department of Public Services. Roll call: Councilmembers Stockford – yes; Mayor Sessions – yes; Councilmembers Bell – yes; Stack-Davis – yes; Dixon – yes; Flannery – yes; Sharp – yes.

Motion carried 7-0.

D. Designation of "councilperson" submitted by Council member Bell

Councilman Bell presented Council with a drafted resolution stating the use of "councilperson" when addressing members of the council be discontinued and instead be addressed as "councilman or councilwoman" respectively.

Mayor Sessions strongly expressed his concerns with the resolution stating it violated his 1st Amendment rights and bordered on discrimination. Mayor Sessions stated he would refuse to sign the resolution should it pass as he considered it to be unlawful. After debate and lengthy council discussion, Councilman Bell withdrew his proposed resolution.

City Manager Report

City Manager David Mackie reported the City was rewarded a \$28,200.00 with a \$3,100.00 match by the City for the purchase of fire department turnout gear (helmets, boots, and gloves). Mr. Mackie also reported the Board of Public Utilities had been awarded a grant in the amount of \$30,000.00 with a \$48,000.00 match by the City for new lighting.

City Manager Mackie stated the Board of Public Utilities would be holding a meeting on December 22, 2015 at 5:00 p.m.to determine their recommendation for the appointment of the new BPU Director.

Lastly, Mr. Mackie reported the Airport Advisory Committee held a meeting on Saturday, December 19, 2015 to discuss future projects in the continuing efforts to clean up and move the airport forward in its improvements.

Council member Stack-Davis inquired about the progress of the airport manager search. City Manager Mackie responded that there had been two inquiries into the position and that the City had published the opening as well.

Council member Flannery commented that he had received several complaints regarding the new lighting at Sharp and Manning

Councilman Bell commented on the violation of rules of procedure by Council. Councilman Bell stated he had submitted a resolution that did not appear on the agenda by decision of the City Manager. Mr. Bell stated the resolution addressed change to public comment and how it is received at council meetings as well as changing the procedure for introduction of agenda items to appear for Council discussion.

Council member Sharp expressed his disappointment in not appointing the City Clerk at the December 21, 2015 meeting. Mr. Sharp suggested the appointment be made at the January 4, 2016 meeting and that information be providing regarding the candidates for review by members of council prior to the January 4, 2016 meeting.

Council member Stack-Davis stated she had done some research on the candidates and that she would like for Council to possibly interview one of the candidates in order to clarify some of the information regarding one in particular.

Council member Flannery concurred with council member Sharp about not appointing the City Clerk as was expected and not having the proper information necessary in order for Council to make a decision regarding the approval of the appointment.

Council member Stack-Davis mentioned the need for public comment both at the beginning and end of each council meeting to open to anything the resident feels the need to comment on.

Council member Stockford agreed that general public comment should be at the beginning of council meetings.

Councilmembers continued to discuss pros and cons of general public comment.
